Year 8 Residential to London - June 2024

We are pleased to offer all students in Year 8 the opportunity to travel to London as part of the June 2024 residential programme (Monday 24th June – Friday 28th June 2024).

The aim of this programme is to provide students with a range of cultural and historical experiences which will enhance their knowledge and understanding of London. It will also provide excellent opportunities for the students to experience some of the attractions of London.

It will include the following:

Suggested Itinerary:

- Day 1 Travel to London. Natural History Museum. Check into accommodation. Evening meal.
- **Day 2** Harry Potter London Walking Tour. London Eye and Thames River Cruise. Bowling 2 games and burger meal.
- Day 3 Harry Potter Warner Bros Studio Tour, Wembley Stadium Tour. Dinner at accommodation.
- Day 4 Thorpe Park, Evening meal local restaurant, West End show and dinner in restaurant.
- **Day 5** Check out of the accommodation, return to school.

The cost of this trip is £775, which includes all travel, accommodation, food and excursions. To secure a place on this trip, a deposit of £100 will be required. Please note that payment can <u>only be accepted</u> through your WisePay account by selecting the 'Trip and Visit Payments' icon, selecting this trip and following the instructions, confirming both consent and payment which will open on **Monday 4**th **December 2023** and close on **Monday 18**th **December 2023**.







Whilst we appreciate that this trip is costly due to the current climate, we have organised this well in advance so that parents/guardians can stage payments over the forthcoming months. A detailed payment schedule is attached.

Terms and Conditions

General

Any student leaving Brooke Weston prior to the trip will not be permitted to travel and will forfeit all monies paid.

Non-refundable deposits

All deposits are non-refundable.

Non-refundable payments

Should a student withdraw from the trip or be unable to travel, you will be liable for monies paid to the Travel Company by Brooke Weston in accordance with the detailed payment schedule, unless covered by the insurance or there are students on the waiting list for the trip who are able to take the place. Deposits, in this case, are still non-refundable as Brooke Weston has to pay the administration charges for name changes to the Travel Company.

Health form and emergency contact details

It is a pre-requisite for every trip that students provide a completed and signed form containing details of any existing medical conditions plus details of any medication they are currently taking. Twenty-four hour emergency contact details for students must be provided to us prior to the trip.

Conduct

In the event of persistent or a serious incident of unacceptable behaviour, the Principal reserves the right to remove any student from any trip. Any refund will be at the discretion of the Principal. Students will be required to sign a behaviour contract prior to departure outlining acceptable behaviour. Any student breaking this contract risks attendance on future trips and the most serious cases parents will need to collect their child.

Insurance

Health and travel insurance is included in the price of the trip. Full details can be made available on request.

Force Majeure

Brooke Weston cannot accept liability, make any refunds or pay any compensation where circumstances amounting to 'force majeure' prevent travel. Circumstances mounting to 'force majeure' include any event which the tour company or Brooke Weston could not, even with all due care, foresee or forestall such as (by way of example not by way of limitation) war, threat of war, riot, civil unrest, industrial dispute, terrorist activity, natural or nuclear disaster, fire, acts of God, adverse weather conditions, and all similar events. The final decision concerning the safety and viability of any trip rests with the Principal, who will, where possible consult with parents beforehand.

Payment schedule

Any default in payment, unless previously agreed with the Finance Office, will result in the place being withdrawn. You will be liable for monies paid to the Travel Company by Brooke Weston in accordance with the detailed payment schedule, unless there are students on the waiting list for the trip who are able to take the place.
